Arkansas

University of Arkansas

Waiver of Non-Resident Tuition for Native Americans (Board Policy 250.1)

Native American people who reside in other states but are members of tribes that lived in Arkansas before relocation, and whose names are listed by the tribal government as members, shall be classified as in-state students of Arkansas for tuition and fee purposes on all campuses of the University of Arkansas System.

Arizona

• Arizona Board of Regents Policy (ABOR 4-203.C.8.a-b):

The individual is an enrolled member of an Indian tribe recognized by the United States Department of Interior whose reservation land lies wholly or partially in Arizona and extends into another state and is a resident of the reservation.

For purposes of residency classification, enrollment as a tribal member in a federally recognized Arizona tribe will be sufficient to establish residency for tuition purposes.

A policy granting members of all federally recognized tribes in Arizona in-state tuition — even those who choose to return after attending an institution elsewhere — is helping to retain American Indian students by making educational costs more affordable.

Since the residency classification policy was approved by the Arizona Board of Regents in 2013, the University of Arizona has enrolled 85 undergraduate and 15 graduate students under the exception.

California

UC's Native American Opportunity Plan ensures that in-state systemwide Tuition and Student Services Fees are fully covered for California students who are also enrolled in federally recognized Native American, American Indian, and Alaska Native tribes. This plan applies to undergraduate and graduate students. If you are eligible for the Native American Opportunity Plan, your in-state systemwide Tuition and Student Services Fees will be fully covered by either UC financial aid or another federal, state or other financial aid program. Students with greater financial need can qualify for even more grant support to help pay other educational expenses (like books, housing, transportation, etc.).

Colorado

The Native American Legacy Award (NALA) is an award for qualified students who are citizens of state or federally recognized tribes or descendants of tribally enrolled citizens. In short, you can receive in-state tuition if you are from out of state. This award means your non-resident tuition will be reduced to Colorado resident base tuition. This does not include university fees or differential tuition. The award is based on current tuition rates, which are subject to change each year. The actual NALA tuition rate will be reflected in your estimated cost of attendance, financial aid awards (if applicable), and billing statements.

Fort Lewis College (Durango, Colorado)

Qualified Native American students can attend Fort Lewis College tuition free. However, they are still responsible for paying their student fees, room and board expenses, purchasing books, and any other educational expenses they may have.

For purposes of the tuition waiver, Native American is defined as follows:

"The term Native American shall include all persons of Native American descent who are members of any recognized Native American tribe now under federal jurisdiction, and all persons who are descendants of such members who were, on June 1, 1934, residing within the present boundaries of any Native American reservation, and shall further include all persons of one-half or more Native American blood. Eskimos and other aboriginal people of Alaska shall be considered Native Americans."

University of Northern Colorado

According to <u>Colorado Senate Bill SB21-029</u>, section 23-7-112 IV (b) (effective June 28, 2021), "American Indian students who are registered members of a federally recognized American Indian tribe with historical ties to Colorado" will be eligible for in-state tuition at Colorado public universities and colleges, beginning fall semester 2021-22.

Hawaii

Native Hawaiian students at any of the University of Hawai'i's 10 campuses may apply for the UH-OHA Ho'ona'auao Scholarship Program. The scholarships are funded through a \$1.1-million grant provided by the Office of Hawaiian Affairs (OHA) and administered by the UH Mānoa Native Hawaiian Science and Engineering Mentorship Program (NHSEMP).

The scholarship program has two priority areas:

- 1. to support scholarships for Native Hawaiians who plan to pursue vocational certificates, undergraduate and graduate degrees; and
- 2.to provide wrap-around services for non-traditional Native Hawaiian students in order to help them complete a post-secondary degree or vocational or technical education.

While historically the native Americans indigenous to the region included the Potawatomie, Ojibwa and Odawa tribes, they were driven out of Illinois and the Bureau of Indian Affairs does not list any tribes in Illinois. Nearby states such as Wisconsin and Michigan each list at least a dozen recognized tribes in those states and Indiana also lists one tribe.

Because of the special heritage you enjoy as part of the Ottawa Tribe of Oklahoma, you are allowed to attend Ottawa University free of any tuition or room and board charges. This is due in part to the renewal and expansion of the original agreement by Chancellor Kevin Eichner in 2008. Since the agreement's expansion, we have enjoyed more Tribe members on campus than ever before.

Maine

The University of Maine System has tuition waiver and room and board grant programs for eligible Native American students. The purpose of these programs is to encourage Native American students to participate in public higher education in Maine. The goal is to provide sustained support for all UMS Native American students who wish to pursue post-secondary study and, in particular,

those who wish to obtain a certificate and/or an associate, baccalaureate, or graduate degree or some other appropriate credential that will serve them personally and professionally as they plan for the future.

• Native American Waiver Program

This program covers tuition and mandatory fees. Tuition and mandatory fees will be waived for qualified students, both matriculated and non-matriculated, who are enrolled in academic, credit-bearing courses at the undergraduate, graduate, or continuing education level at the campuses of the University of Maine System. Mandatory fees are required fees charged of all students enrolled at the institution and automatically assessed at the time of registration exclusive of fees associated with contracted training or other educational activities provided by an external agency, business or organization including but not limited to travel and accommodation fees related to travel courses and other extraordinary fees such as health insurance.

• Native American Room and Board Grant

The Native American Room and Board Grant is a need-based award for qualified native students living in a residence hall of the campus where they are matriculating. Students will be subsidized at the double occupancy rate for the student's residence. Charges for single, double single, or computer or telephone devices, for which there is a separate charge, will be the responsibility of the student tenant. Room and board charges will be covered only during the traditional academic year (fall and spring terms).

Massachusetts

Over the last two decades the Massachusetts Commission on Indian Affairs has assisted in the determination of eligibility of Native Americans in Massachusetts for tuition waivers at state colleges and universities. It is authorized by the Board of Education to certify that individuals are of Native American descent and eligible for the tuition waiver.

The Commission uses membership in a Massachusetts tribal group (tribe, band, or clan) that is acknowledged by the Commission as a legitimate, historical tribal group as a criterion for making recommendations about tuition waivers. In addition, the Commission uses official state and federal recognition status for issuing tuition waivers to individuals whose tribes are located outside of Massachusetts.

To be eligible for a tuition credit, the applicant must: (1) Be Native American; (2) Be a Massachusetts resident; (3) Be enrolled in a degree program at a Massachusetts college or university.

As of Fall 2022, newly admitted University of Minnesota freshmen undergraduate students and transfer students from one of the four Tribal colleges in Minnesota who are enrolled citizens of one of the 11 federally recognized Tribal Nations in Minnesota, who complete the Free Application for Federal Student Aid (FAFSA) and meet income requirements will automatically be considered for Native American Promise Tuition Program. Prospective students for Fall 2022 and beyond, at any of the five U of M campuses must establish eligibility within their first enrollment year (either as a new freshman or transfer student from one of the 4 Tribal Colleges). Students enrolled prior to Fall 2022 are not eligible for this program.

University of Minnesota Morris

The University of Minnesota Morris will admit American Indian students qualified for admission free of charge for tuition, as mandated in federal law and state statute.

Students with American Indian heritage are admitted to the University of Minnesota Morris on the same basis as other students. For the purposes of this tuition waiver, American Indian is defined as: an enrolled member of a federally recognized American Indian tribe, Alaskan Native Village, or Canadian First Nation; a direct descendant of a parent or grandparent who is an enrolled member of a federally recognized American Indian tribe, Alaskan Native Village, or Canadian First Nation; or a direct descendant of a tribally verified member of a federally recognized American Indian tribe, Alaskan Native Village, or Canadian First Nation, other than parent or grandparent. American Indian students do not need to establish residence on trust lands, nor do they need to be Minnesota residents.

The Montana Board of Regents adopted <u>Policy 940.13</u> in order to increase access to higher education for resident American Indian students. The policy requires that the campuses of the Montana University System waive tuition for eligible undergraduate American Indian students. During the 2018-2019 school year, the Montana University System waived over \$2.9 million in tuition for 832 American Indian students. Although this policy is sometimes called a fee waiver, it allows only waivers of tuition. Fees, program fees and other charges are not waived by this policy.

Persons who have at least one-fourth (1/4) degree Indian blood or are enrolled members of a state recognized or federally recognized Indian tribe which is located within the boundaries of the State of Montana may be eligible for a waiver upon demonstration of financial need. "Financial need" is defined as having at least one dollar of remaining need after subtracting Expected Family Contribution, all Title IV grant aid and institutional aid from the cost of attendance. Duplication of tuition designated awards is not allowed.

The campuses follow federal financial aid guidelines in awarding and renewing tuition waivers. These rules may be obtained from the financial aid office on each campus. Students may continue to receive these waivers from year to year, if they make reasonable academic progress. Students should check each campus's policy about satisfactory progress.

This scholarship program has been designed to assist in funding American Indian students education at Northeastern State University. Those students eligible for the program will receive a non-resident tuition waiver scholarship for 100% of their non-resident tuition. Non-Resident tuition is \$288 per hour for undergraduates and \$314.50 for graduate students, in addition to in-state tuition. Students are responsible for paying the in-state portion of their tuition.

Oregon

The Oregon Tribal Student Grant program was established to provide grants to eligible Oregon tribal students to offset the cost of attendance for attending eligible Oregon colleges and universities. Current continuing and new students are encouraged to apply for this grant for the 2022-2023 academic year.

The grant is intended to cover the average cost of attendance after all federal and state grants/scholarships have been applied.

Starting with the fall term 2022, Oregon State University students who are enrolled members of the 574 federally recognized Tribes as included on the Federal Register, shall be considered residents of the state of Oregon for tuition purposes. This policy shall include enrolled members of any Tribes added to the Federal Register in future years. The policy shall apply to tuition charged for any forcredit course offered at OSU, whether at the undergraduate or graduate level, and as a part of any academic program, including but not limited to degree, certificate, digital badges, or course sequences.

Portland State University

Portland State University's (PSU) Native American Tuition Program (NATP) ensures that undergraduate students who are enrolled members of any one of the U.S. Federally Recognized Tribes will pay the equivalent of resident tuition regardless of their state or country of residence. This discount cannot be used to pay for housing costs at PSU.

Utah

Washington

• "Resident Tuition Rates - American Indian Students," RCW 28B.15.0131. This Washington statute focuses on in-state tuition for residents of Washington state and neighboring states who are members of federally recognized tribes with historical ties to their state. It reads:

For the purposes of determining resident tuition rates, resident students shall include American Indian students who meet two conditions. First, for a period of one year immediately prior to enrollment at a state institution of higher education as defined in RCW 28B.10.016, the student must have been domiciled in one or a combination of the following states: Idaho; Montana; Oregon; or Washington. Second, the students must be members of one of the federally recognized Indian tribes whose traditional and customary tribal boundaries included portions of the state of Washington, or whose tribe was granted reserved lands within the state of Washington. Federal recognition of an Indian tribe shall be as determined under 25 C.F.R. by the United States bureau of Indian affairs.

Any student enrolled at a state institution of higher education as defined in RCW 28B.10.016 who is paying resident tuition under this section, and who has not established domicile in the state of Washington at least one year before enrollment, shall not be included in any calculation of state-funded enrollment for budgeting purposes, and no state general fund moneys shall be appropriated to a state institution of higher education for the support of such student.
